DECISION OF THE EXECUTIVE COUNCIL :

RESOLVED that the South Salmara College be granted permanent affiliation TDC Part-II(Arts) General Course from the Session 2010-11 on receipt of prior Concurrence of the State Govt. as per G.U. Act 1947 as amended upto date on the following subjects.

Subjects :- English, Assamese (MIL & Elective), Economics, Education, History, Mathematics, Political Science and Arabic.

The College be directed to fulfil the following conditions.

- (1) To obtain the State Govt. Concurrence and submit the same to the University for necessary consideration.
- (2) To increase the number of books in the Library.
- (3) To increase the number of students in Mathematics.

RESOLVED also that the College be informed of the following conditions.

- (i) **Withdrawal of Affiliation** : The Executive Council on the Recommendation of the Affiliation Committee by a resolution shall have the power to withdraw any affiliation or permission from a College at any time. Whenever, if in the opinion of the Executive Council, the College has failed to comply with Statutes, Ordinance, Rules, Regulations or any other directives of the University or the College authorities have failed to maintain order and discipline in the College or the normal and proper functioning of the College has become impossible due to mismanagement of the affairs of the College or for any reason.
- (ii) The Annual fee of Rs. 3500/- (Rupees Three thousand five hundred) per faculty of the College be paid per year by the College.
