It is hereby informed that this shall be the last and final round of Lateral Entry Admissions and no further extension shall be granted. All Higher Education Institutions are, therefore, requested to ensure that the scrutiny and admission of eligible applicants are completed within the stipulated timeline through the **Lateral Entry Portal of Assam SAMARTH**.

NOTIFICATION

In view of the late declaration of results of National Institute of Open Schooling (NIOS), Assam State Open School (ASOS) and requests received from various Higher Education Institutions and the student community, and in the larger interest of the students, a **last and final admission round** for Under-Graduate, Post- Graduate and ITEP First Year for the Academic Session 2026-27 will be conducted from 10th to 15th September 2026 through Assam SAMARTH Portal.

The registration and programme selection by applicants will remain open from 10th to 14th September 2026, while the scrutiny of applications and the admission process will close on 15th September 2026.

Only those applicants who have not taken admission in any HEIs will be eligible to take admission during this round. No cancellation/withdrawal option will be available during this round.

Further, all HEIs concerned, who had not conducted admissions to any Programmes through Samarth portal are hereby directed to complete the admission process of the enrolled students through Samarth.

Students admitted during this last and final admission round will not be able to avail the benefit under Mukhya Mantrir Nijut Moina Aasoni / Mukhya Mantrir Nijut Babu Aasoni only for the month of October. Such students will, however, be eligible to receive benefits under both the schemes from the month of November.

It is also to informed that all HEIs onboarded on Assam SAMARTH should conduct all FYUGP/ FYIMP and PG Admissions only through the SAMARTH Portal and are strictly directed not to conduct the admissions through offline or web portal of respective Institutions.
